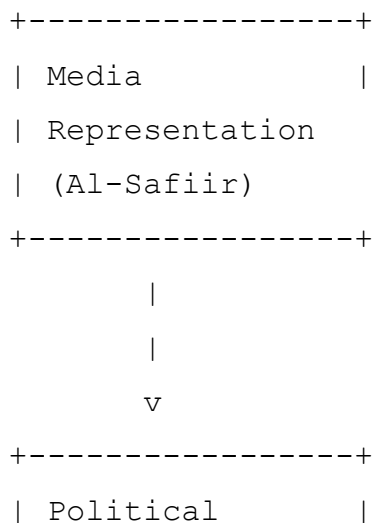
#### 1. Media Representation
